INDEMNITY FORM

I,, being the lawful parent or guardian of
..... hereby agree:

1. That Aqaba International School, or any teachers, or officials, or voluntary helpers of the school, shall have no responsibility of whatsoever nature in respect of bodily injury to the above child:
